- 1. Q: Can you give your full names to the Commission?
- 2. A: My name is Isatou Jallow, Executive Director of Guaranty Trust Bank.
- **3.** Q: What is your role in the Bank?
- 4. A: **Executive Director** and also **Regional Head of Corporate Bank**.
- 5. Q: Where do you live?
- 6. A: Brusubi.
- 7. Q: How long have you worked in the Bank?
- 8. A: I have been with the Bank since April 2003.
- 9. Q: You were required to produce documents relating to all the accounts that GNPC (Gambia
- **10.** National Petroleum Corporation) has in the Bank?
- **11.** A: Yes.
- **12.** Q: How many accounts do they have?
- 13. A: They have **One on One account** like we mentioned last time. **One on One account**; that
- 14. is the Current account. They have a Call account -.
- 15. Q: The last time, the Managing Director gave evidence on the Special Services Accounts;
- 16. which is the **Ministry of Petroleum** account. You are going to give evidence on the **GNPC**
- **17.** actual account?
- **18.** A: Sure.
- **19.** Q: Let's take them one at a time and give us the numbers?
- **20.** A: We have **210108217110**.
- **21.** Q: What is the currency?
- 22. A: Its Dalasi Account; Current account.
- **23.** Q: When was it open?
- **24.** A: It was opened on the  $10^{\text{th}}$  of September 2008.
- **25.** Q: Give us the next account number?

- 26. A: The next account is 2011082171150. This is a Dalasi account. It's a Current account but
- 27. it's a **Call account**; **Interest bearing account**.
- **28.** Q: It's a **Call account**?
- **29.** A: Yes, it's an **Interest bearing account**.
- **30.** Q: What does a **Call account** mean?
- **31.** A: We pay interest on it.
- **32.** Q: Which means it's a Current account you pay interest to it?
- **33.** A: Yes we pay interest.
- **34.** Q: When was it open?
- **35.** A: It was opened on the  $5^{\text{th}}$  of January 2010.
- **36.** Q: Next account?
- **37.** A: We have **201108217210**. It's a **Dollar account**.
- **38.** Q: Opened?
- **39.** A: It was opened the  $19^{\text{th}}$  of March 2009.
- **40.** Q: Next?
- 41. A: The next one is 201108217211. This is another **Dollar account**; it's a sub account. It was
- 42. opened on the  $26^{\text{th}}$  of May 2014.
- **43.** Q: Next?

- **45.** September 2015.
- 46. Q: Let's go back to the GMD Account?
- **47.** A: Ok.
- 48. Q: Who are the signatories when it was opened and tell us about the change of signatories?
- **49.** A: There we have **Momodou O.S. Badjie** who was added on the 24<sup>th</sup> of April 2009. That
- 50. was the first mandate that we have because at some point he was deleted and then re-added.
- **51.** Q: Who open the account?

<sup>44.</sup> A: Then we have the last one 2011082174610. It's a Euro account. Opened on the 11<sup>th</sup> of

- **52.** A: They opened the account.
- **53.** Q: This **Momodou Badjie**?
- 54. A: Yes. Momodou .O.S. Badjie.
- **55.** Q: With whom?
- 56. A: What we have is Malick Jarju. Malick Jarju was the Accountant. But we don't have
- 57. Malick as part of the mandate. The mandate we have Ebrima .O. Camara, the same date 24<sup>th</sup> of
- 58. April 2009. We have Fafa Sanyang -.
- **59.** Q: **Momodou O.S. Badjie**, what was his title at the time?
- **60.** A: He was the Managing Director.
- **61.** Q: What about **Ebrima .O. Camara**?
- **62.** A: He was the Permanent Secretary as then.
- **63.** Q: Of which Ministry?
- 64. A: It was not specified there.
- 65. Q: It just said 'Permanent Secretary'?
- **66.** A: Yes Permanent Secretary.
- 67. Q: Is there anything in the document which suggests or indicates the Ministry? Can you look
- **68.** at the account opening documentation?
- **69.** A: It's not specify.
- 70. Q: And that was sufficient for the Bank?
- **71.** A: Yes as the mandate.
- 72. Q: Surely if it says 'Permanent Secretary' it's a title that doesn't exist in a company which
- 73. GNPC was at the time. Would that be required to find out what Ministry he was Permanent
- 74. Secretary of?
- **75.** A: Surely.
- 76. Q: But it is not indicated?
- 77. A: Here it is not indicated.

- **79.** documentation to the **Commission**?
- 80. A: Ok. No problem. We also have Fafa Sanyang.
- **81.** Q: Title?
- 82. A: Fafa was the Commissioner of Petroleum.
- **83.** Q: Commissioner Petroleum?
- 84. A: Yes Commissioner of Petroleum.
- **85.** Q: That's all for this?
- 86. A: No, we have **Teneng M. Jaiteh.**
- **87.** Q: All on the same date?
- **88.** A: Yes all on the same date 24<sup>th</sup> of April 2009. **Teneng** was the Secretary General.
- **89.** Q: Office of the President?
- **90.** A: It's not specified, it just said Secretary General.
- **91.** Q: On the 24<sup>th</sup> of April that is what you have?
- **92.** A: Yes 24<sup>th</sup> of April on the same date.
- **93.** Q: Was there any subsequent change to the signatories?
- 94. A: Sure. We have other signatories.
- **95.** Q: Tell us about the changes?
- 96. A: For Momodou O.S. Badjie, he was deleted on the 28<sup>th</sup> of July 2016 and re-added on the
- **97.** 28<sup>th</sup> of June 2017 but he was deleted again on the 31<sup>st</sup> of August 2017. **Ebrima O. Camara** was
- 98. deleted on the 28<sup>th</sup> of July 2016. Then we have **Fafa Sanyang**, **Fafa** was also deleted 28<sup>th</sup> of July
- **99.** 2016. **Teneng .M. Jaiteh** was also deleted on the 8<sup>th</sup> of September 2016.
- **100.** Q: All in 2016?
- **101.** A: Yes.
- **102.** Q: So you are saying between 2009 up to 2016 there were no changes?
- **103.** A: No, there are other signatories because there are a lot of signatories in the account. I

104.	think we have to go one by one. We have Medoune Sanyang; Medoune was added on the 7th of		
105.	February 2011 but deleted on the 8 <sup>th</sup> of September 2016, Medoune Sanyang. Then we have		
106.	Tsung Wen Shiao, he was added 29 <sup>th</sup> of October 2012 and was deleted 28 <sup>th</sup> of July 2016. Then		
107.	we ha	we the former President Yahya A.J.J. Jammeh; that was not on the Dalasi, it was only on	
108.	one a	ccount, that's the Dollar Account.	
109.	Q:	You know we are talking about the GMD that is the Dalasi Account. Are you now	
110.	saying these signatories you have been telling us about were in respect of all the accounts?		
111.	A:	Up to 2013 on the main <b>Dollar Account.</b>	
112.	Q:	What I want to understand; you were giving evidence on the signatories?	
113.	A:	Yes.	
114.	Q:	I assumed you were giving evidence only on the Dalasi Account?	
115.	A:	Yes.	
116.	Q:	Are you now saying that you are giving evidence only?	
117.	A:	These were signatories on the <b>Dalasi Account</b> and then the <b>Dollar Account</b> as well.	
118.	Q:	And the <b>Dollar Account</b> ?	
119.	A:	Yes then until on the 14 <sup>th</sup> of August when they seized to be signatories on the main	
120.	<b>Dollar Account</b> that is the <b>210 Account</b> .		
121.	Q:	Let's just assume we are dealing with the <b>Dalasi Account</b> first. Then we can adopt part	
122.	of your evidence for the rest of the accounts if it is relevant?		
123.	A:	Ok.	
124.	Q:	Let's go back to the Dalasi Account. You were just telling us about the Ex-President.	
125.	Was he a signatory to the <b>Dalasi Account</b> ?		
126.	A:	To the <b>Dollar Account</b> .	
127.	Q:	He was not a signatory to the <b>Dalasi Account</b> ?	
128.	A:	No, he was not a signatory to the <b>Dalasi Account</b> but the <b>Dollar Account</b> .	
129.	Q:	Have you concluded your evidence as to the signatories on the Dalasi Account?	

130.	A:	No.
131.	Q:	Can you finish that please?
132.	A:	We have Momodou Sabally; Momodou was also a signatory to only the
133.	Dollar	Account.
134.	Q:	Let's leave the <b>Dollar Account</b> , let's finish the <b>Dalasi Account</b> . Are there any other
135.	signato	ries to the <b>Dalasi Account</b> you want to tell us about?
136.	A:	Sure there are signatories there. We have Alfred Alfred George Belford, he was added
137.	on the	16 <sup>th</sup> of March 2016 but deleted on the 8 <sup>th</sup> of September 2016. Then we have
138.	Babou	carr Njie; Baboucarr was added on the 28 <sup>th</sup> of July 2016 and deleted 15 <sup>th</sup> of March 2017.
139.	We have Lamin Manneh; Lamin was added on the 8 <sup>th</sup> of September 2016 and deleted on the	
140.	19 <sup>th</sup> of .	July 2017. We have <b>Abdoulie T.B. Jarra</b> ; <b>Abdoulie</b> was also added on the 15 <sup>th</sup> of March
141.	2017, h	e is still a signatory to the Account. We Cany Jobe Taal; Cany is also a signatory.
142.	Q:	Added when?
143.	A:	Added on the 11 <sup>th</sup> of May 2017.
144.	MS.A.	BENSOUDA: That is fine. We are really only interested up to January 2017. Let's go
145.	back a	little bit. We need to have the titles of these people to be consistent.
146.	Q:	You said <b>Teneng .M. Jaiteh</b> was Secretary General?
147.	A:	Yes.
148.	Q:	So Mr. Medoune Sanyang was what when he was added?
149.	A:	Medoune was the Finance Manager.
150.	Q:	Mr. Tsung Wen Shiao?
151.	A:	The title is not mentioned.
152.	Q:	His connection to the Company is not indicated?
153.	A:	He is a signatory but his title is not mentioned; there is nothing like that. We don't have
154.	anythin	g in place like that.
155.	Q:	What about Mr. Belford, Baboucarr Njie, Lamin Manneh and Abdoulie Jarra; there

- **156.** titles are indicated whether or not?
- 157. MS.A. BENSOUDA: If you can't find it for now, we will have to look at it.
- **158.** Q: Now this is the **Dalasi Accounts** signatories?
- **159.** A: Yes.
- **160.** Q: Now you have a 2<sup>nd</sup> Dalasi Account; does the same signatories apply?
- 161. A: Sure, these are the signatories for the 2<sup>nd</sup> Dollar Account as well; that's the 211.
- 162. Q: We have two Dalasi Accounts. You gave us two Dalasi Accounts?
- **163.** A: Yes.
- 164. Q: My question is whether the signatories you have just indicated apply to the  $2^{nd}$  Dalasi
- **165.** Account as well?
- **166.** A: Sure.
- 167. Q: Let's move on to the **Dollar Account 201108217210**; that is the 1<sup>st</sup> one and there is a
- 168. second one ending in 721. Those are the two Dollar Accounts?
- **169.** A: **210** and **211**.
- 170. Q: Now what is the difference first between these two **Dollar Accounts**; why two?
- **171.** A: Yes I think the signatories were different.
- 172. Q: No, in terms of the accounts themselves. What is the difference? Why two Dollar
- **173.** Accounts? That is what I want to understand.
- 174. A: What I am saying, like these signatories I mentioned, they were signatories to that 210
- 175. Account until August 2014 when they seized to be signatories to that account. The President then
- **176.** became a signatory to the account.
- 177. Q: I understand there were changes in signatory. What I want to know is; what is the
- 178. difference between these two accounts, the money that goes into them different? Why two
- **179. Dollar Accounts** and not **one Dollar Account**?
- 180. A: Like I said, I know the signatories are different like the President was managing the 210
- 181. Account whilst the Corporation was also managing the 211 Account.

- **182.** Q: Tell us about the **210 Account**. Who opened the **210 Account**?
- 183. A: The 210, Momodou Badjie and Co. opened the 210 Account like I said which was
- **184.** opened on the 19<sup>th</sup> of March 2009 until 14<sup>th</sup> of August 2013 when they seized to be signatories.
- **185.** Q: Tell us about the change of signatories?
- **186.** A: We have a letter advising us to change signatories.
- **187.** Q: Where did the letter emanate from?
- **188.** A: The letter was from **Gambia National Petroleum** then.
- **189.** Q: Signed by who?
- **190.** A: Signed by the former **MD Momodou .O.S. Badjie**, the Managing Director and also
- **191.** Medoune Sanyang the Finance Manager.
- **192.** Q: And it says the signatories should change to?
- 193. A: Yes signatories to change to Sheikh Professor Alhaji Dr. Yahya A.J.J. Jammeh and
- **194.** Momodou Sabally.
- **195.** MS.A. BENSOUDA: Let's have that letter.
- **196.** Q: Do you have the Statement of the **210** Account?
- **197.** A: Sure, we have it.
- **198.** Q: As at the time the signatories were changed on the 13<sup>th</sup> August 2013. What was the
- **199.** balance in the account?
- 200. A: The balance in the account then was \$1, 241, 513. 38 (One Million Two hundred and
- **201.** forty-one thousand Five hundred and thirteen Dollars and Thirty-eight Cents).
- **202.** Q: How much money went into the account after the signatories were changed?
- 203. A: What went into the account was 2, 266, 266. 29 (Two Million Two hundred and Sixty-six
- **204.** thousand Two hundred and Sixty-six point Twenty-nine).
- 205. Q: This is an additional amount that went into the account after the signatories were
- **206.** changed?
- 207. A: Yes.

- **208.** Q: What was the balance in the Account as at  $21^{st}$  of January 2017?
- **209.** A: **81, 112. 19** (Eighty-one Thousand One hundred and twelve point One nine).
- **210.** Q: Do you have the transaction documents relating to the Account?
- **211.** A: Yes.
- **212.** Q: From what date do you have the transaction documents?
- **213.** A: Though we have from inception but we also have from the day the Ex-President was
- **214.** added as a signatory.
- **215.** Q: Do you have two copies of the Statement?
- **216.** A: Sure we have a copy here.
- **217.** Q: Let's have the Statement?
- **218.** A: It's here.
- **219.** Q: What we would like you to tell us about the withdrawals from the account from change of
- 220. signatory on the 13<sup>th</sup> of August 2013? Let me just confirm something since the signatories were
- 221. changed on the 13<sup>th</sup> August 2013. Was there any other change to the signatories to the account?
- **222.** WITNESS: That **Dollar Account**?
- 223. MS.A. BENSOUDA: Yes.
- 224. A: Yes, there were other changes. Other Secretary Generals were signing. It depends on -.
- **225.** Q: Tell us about the change of signatories first?
- **226.** A: We have **Abdoulie Momodou Sallah**.
- **227.** Q: When was he added?
- **228.** A:  $7^{\text{th}}$  of July 2014 and deleted  $3^{\text{rd}}$  of September 2014.
- **229.** Q: Go on?
- **230.** A: Then we have **Kalidou Bayo** who was also added 3<sup>rd</sup> of September 2014 and deleted
- **231.** 28<sup>th</sup> of July 2016.
- **232.** Q: Is that all?
- **233.** A: No. We have **Sulayman Samba** who was added 8<sup>th</sup> of September 2016 and deleted

234. 19th of July 2017. But this guy was also a signatory to the GMD Account as well, the Dalasi

**235.** Account as well.

- **236.** Q: That's **Mr. Sulayman Samba**?
- **237.** A: Yes.
- **238.** Q: He was added to the **Dalasi Account**?
- **239.** A: Yes to the **Dalasi Account**.
- **240.** Q: When was he added?
- **241.** A: The same day,  $8^{th}$  of September 2016.
- **242.** Q: That was the last change?
- 243. A: No, then we have Adama Ngum-Njie. Adama was a signatory to the Dalasi Account as
- **244.** well. **Adama** was added the same day 8<sup>th</sup> of September 2016, deleted 19<sup>th</sup> of July 2017.
- **245.** Q: That's it?
- **246.** A: That's all.
- 247. Q: Can you hand over the signatory documentation? Does it apply to all accounts?
- **248.** A: The signatory documentation -.
- **249.** Q: Do you have separately for the **Dollar Account**?
- **250.** A: We don't have separately for the **Dollar Account**.
- 251. Q: Let's go to the transaction on the Dollar Account ending in 2010. The transactions after
- 252. 13<sup>th</sup> or on from 13<sup>th</sup> August 2013? How many withdrawals are we talking about? Do you have a
- **253.** summary?
- **254.** A: No we don't have a summary of the withdrawals. But it is not much.
- **255.** Q: Tell us about it and hand over the transaction documents?
- 256. A: We have there on the 20<sup>th</sup> September 2013, there was a debit of 76, 379.54 (Seventy-six
- 257. Thousand Three hundred and seventy-nine point Five four). We have an instruction but it also

258. said "Transfer between customers transfer from GNPC going to GICEC".

**259.** Q: What is **GICEC**?

- **260.** A: Is a construction company.
- **261.** Q: How did you receive the instructions?
- 262. A: We have a transfer request. They have an account with us; GICEC has an account with
- **263.** us.
- **264.** Q: Was it a letter?
- **265.** A: Yes it was a letter.
- **266.** Q: Written by who?
- **267.** A: It was a letter signed by **Momodou Sabally** and the Ex-President **Yahya Jammeh**.
- **268.** Q: What is the date?
- **269.** A: 19<sup>th</sup> of September 2013.
- **270.** Q: **GICEC** is obviously an abbreviation or an acronym?
- **271.** A: GICEC is Guangzhou International Construction and Engineering Company.
- **272.** Q: And the payment was made?
- **273.** A: Yes the payment was made.
- **274.** Q: To an account with **GT Bank**?
- **275.** A: Yes to their account with **GT Bank**.
- **276.** Q: Can you hand over the transaction documents?
- 277. A: Ok, yes. We have a transfer of €650, 000 (Six hundred and fifty thousand Euros). It was a
- 278. swap. But the debit amount in Dollar was \$884, 000 (Eight Hundred and Eighty-four thousand
- **279.** US Dollars).
- **280.** Q: What date?
- **281.** A: Their instruction was dated 4<sup>th</sup> of November. The debit was 5<sup>th</sup> of November but the
- **282.** instruction was 4<sup>th</sup> of November 2013.
- **283.** Q: Tell us about the transaction?
- **284.** A: The money went through **United Nations Office of Project Services**.
- **285.** Q: Instructions sign by?

- **286.** A: Instructions signed by **Momodou Sabally** and Ex-President **Yahya A.J.J. Jammeh**.
- **287.** MS.A. BENSOUDA: Hand it over.
- **288.** Q: Next transaction?
- 289. A: The next transaction is; this is a CFA transaction. The instructions that we have is CFA
- 290. but what they told us that is either equivalent in Euros, we can transfer that equivalent in Euros.
- 291. So the Euro equivalent was €121, 483.11 (One hundred and twenty-one thousand Four hundred
- 292. and eighty-four point Eleven Euros). But the Dollar debit was 151, 246.47 (One hundred and
- **293.** fifty-one thousand Two hundred and forty-six point Forty-seven).
- **294.** Q: Paid to who?
- **295.** A: Paid to **Cosetam**.
- **296.** Q: Is it a company?
- **297.** A: Cosetam SABP.
- **298.** Q: It's a foreign transfer?
- **299.** A: Yes it's a foreign transfer.
- **300.** Q: What country?
- **301.** A: The bank that it went to is **BNP Paribas**.
- **302.** Q: In which country? That's the telex transfer you are reading from?
- **303.** A: Yes. But the country is not mention.
- **304.** Q: The bank account?
- **305.** A: The Bank account we have the **IBN** is **R7630004024790001061945447** and signed by
- **306.** Momodou Sabally and the Ex-President.
- **307.** Q: The address of the bank is not indicated; isn't that usual?
- **308.** A: No the address of the beneficiary is here; it's **Nomani**.
- **309.** Q: Whose address; the bank or the beneficiary?
- **310.** A: The beneficiary bank; that is the Bank.
- **311.** Q: That's **Cosetam**?

**312.** A: No, **Cosetam** is the account name.

**313.** Q: Who is the beneficiary?

- **314.** A: We have the beneficiary, we have the beneficiary bank. The beneficiary name is the
- **315.** Account name.
- **316.** Q: The beneficiary name is the Account name?
- **317.** A: Yes the beneficiary name is the account name. It's the same.
- **318.** Q: And is it consistent with the instructions that you have to pay to **Cosetam**?
- **319.** A: Unless we go to other instructions and see whether we have -.
- **320.** Q: You are here to help us, tell us where the money went?
- 321. A: Yes that is what I am saying; that is the beneficiary, the beneficiary is Cosetam. And
- **322.** then we have the beneficiary bank, that is the **BNP Paribas**.
- **323.** Q: The instructions that you have, can you read it to us please?
- 324. A: The instructions that we have, we said "We the undersign hereby request you to transfer
- 325. the sum of CFA79, 687, 693.5 (Seventy-nine Million Six hundred and eighty-seven thousand
- 326. Six hundred and ninety-three point five) or its equivalent in Euro from the Gambia National
- 327. Petroleum Company then Account No. 201108217210".
- **328.** Q: That's all it says; the letter?
- 329. A: To the account then we have the account name that is Cosetam. Then we have the

**330.** beneficiary bank, we have the **BIT** and then we also have the **IBAN**.

- **331.** Q: Can you hand it over?
- **332.** A: Ok.
- **333.** Q: But we do expect a bank to know which country money is going to?
- **334.** A: We can look out for that. We can check that one further.
- **335.** Q: You are saying you can check that?
- **336.** A: I said we can find out further. We can find out from the telex and see whether -.
- **337.** Q: You don't have the telex with you?

**338.** A: We don't have that telex here.

339. MS.A. BENSOUDA: I think we will require more specifics in relation to this transaction. It is a 340. significant amount of money going out of your Bank and we expect better documentation on that. 341. **O**: Let's move on to the next transaction? 342. A: The next transaction, is a transfer request of **\$66, 064.97** (Sixty-six thousand and Sixty-343. four Dollars and Ninety-seven Cents) also to GICEC's account with GT Bank. 344. Q: Can you hand over the documents that you have referred to so far in respect of Cosetam 345. and **GICEC**. The next transaction? What date is the **66**, **064** (Sixty-six thousand and Sixty-four)? 346. A: 3<sup>rd</sup> of December 2013. Then the next one is **21, 338. 30** (Twenty- one thousand Three hundred and thirty-eight point Thirty), it was also a payment to **GICEC** on the 26<sup>th</sup> of February 347. 348. 2014. 349. Next? Q: 350. A: There is a debit for **\$28, 810** (Twenty-eight thousand Eight hundred and ten Dollars), that's on the 6<sup>th</sup> of March 2014. This was a transfer. It's going through a beneficiary name called 351. 'Plats'. 352. 353. Q: **Beneficiary called?** 354. A: Here they said "To the beneficiary account given below as payment for market data 355. CSV subscription fee". 356. **O**: That's a withdrawal? It's a payment? 357. A: Yes it's a payment. 358. **O**: Authorize by who? 359. A: Authorize by Momodou .O.S. Badjie. Though what was quoted here was the Dalasi 360. Account, It was signed by Momodou .O.S. Badjie and Medoune Sanyang. But they were not 361. signatories to this account by that time. I think what we have to do; I don't know whether we will 362. see any document relating to - - because instead of debiting the **Dalasi Account**, we debited the 363. **Dollar** Account.

- **364.** Q: Are you saying that was a mistake?

- 424. the Ex-President Yahya A.J.J. Jammeh. Some has purpose though; the GICEC. We have
- 425. \$1, 14, 165. 60 (One million Fourteen thousand One hundred and sixty-five point Sixty Dollars),
